PRIVACY POLICY (Art. 13 / EU Regulation 2016/679)

The General Data Protection Regulation 2016/679 replaces the Legislative Decree no. 196 dated June 2003 in its entirety. The Regulation establishes that the interested party must be informed in advance about the use of data concerning him and that the processing of personal data is allowed only with the express consent of the interested party except in those cases foreseen and regulated by Art. 06, and specifically under point b) the treatment is necessary for the execution of a contract of which the interested party is a party or for the execution of pre-contractual measures taken at the request of the same; c) the processing is necessary to fulfill a legal obligation to which the holder of said processing is subject to processed in compliance with current legislation regarding corporate and industrial secrecy

The purpose of Regulation is:

- the full supply of products or services in case of order
- to provide all what foreseen in the contract in the event of sale of accessories
- to monitor the safety of people and the company assets
- to keep track of the navigation carried out on the fixed network or on the available wi-fi in order to protect the same from offenses committed by third parties while browsing on the same
- to send communications on our products or prospects to our customers

The legal basis of the Regulation is constituted by the commercial relationship created by the sale or the purchase of goods and/or services relative to art. 6 par. B and c of this Regulation.

The personal data you provide as person concerned (the physical person to whom the personal data refers) will be processed in compliance with the laws in force, using manual, computerized and telematic tools with logic strictly related to the purposes themselves and may involve all the operations envisaged by art. 2 par. 2 of the Regulation. In any case, all data are processed in compliance with the law and the confidentiality obligations imposed by the same.

Personal data are processed within the normal activity of study, production and sale of labels for the purpose of describing the corporate macro process and all the management and operational activities connected to it (for ex. invoicing, credit protection, other administrative, management and organizational services)

In relation to the aforementioned purposes, no "particular" data (ex from sensitive data) referable to the data subject will be treated.

The provision of personal data to the company for the purposes mentioned above is mandatory because without its data we may not be able to provide you, in whole or in part, the activity you require, you can not access the structure or browse the internet.

The recipients of the data (exclusively for the purposes indicated above and always limited to what is strictly competent in relation to the specific relationship between you and the company), according to the cases, may or should be communicated to the subjects or categories of subjects listed below:

- Public Authorities for inspections and control activities, expressly delegated to them by the Law or which they are institutionally responsible for
- Companies and professionals who perform accounting checks and audits or payroll management on our behalf
- Trusted companies that perform tasks of technical or organizational nature on our behalf; the same also applies to the subjects already indicated in this statement to which the data are communicated

Geographical scope of treatment: your personal data will always be processed within the European community

Storage: your personal data will be processed exclusively for administrative and accounting purposes for a period not exceeding the one established by the current tax legislation for the observation of documents (10 years).
