## Information on the processing of personal data (article 13 – reg. Eu 679/16)

The European Regulation 679/2016 or "General Data Protection Regulation" supports the Legislative Decree June 30, 2003, n. 196, as amended by D.L. 101/18. **The data protection officer (dpo)** is not appointed as Duesse s.r.l. does not fall within the cases of Article 37. **The purpose of the processing** is:

- To pay for the supply of products or services in the case of their provision;
- To provide that which is contractually required in the case of a sale of labels and boxes;
- To monitor the safety of persons and company assets;
- To keep track of navigation carried out on the fixed network and on the available Wi-Fi, in order to protect it from offenses committed by third parties while browsing on the same;
- Send samples through our online catalog;
- Send communication relating to our products to customers or prospective customers, through consent

The legal basis of the processing consists of the commercial relationship created by the sale or purchase of goods and / or services, in relation to article 6 paragraph b and c of this regulation. Or pursuant to Article 6 paragraph a) for the latest processing of data.

The personal data you provide as an interested party (the natural person to whom the personal data refers) will be processed in compliance with the laws in force, using manual, IT and telematics, with logic strictly related to the purposes themselves and may involve all the operations provided for by Article 4, paragraph 2 of the regulation. In any case, all data is processed in compliance with the law and the confidentiality obligations imposed by the same. Personal data is processed within the normal activity of the company, production and sale of labels, for the purposes of describing the company macroprocess, the purpose for which the data is processed, and all management and operational activities related to it (e.g. invoicing, credit protection, other administrative, managerial and organizational services). In relation to the aforementioned purposes, no "special category" data (formerly sensitive data) referable to the interested party will be processed.

The provision of personal data to the company for the purposes indicated above is mandatory as without your data we may not be able to provide you, in whole or in part, the activity you requested, you will not be able to access the facility or browse the internet. The recipients of the data (exclusively for the purposes indicated above and always limited to what is strictly related to the specific relationship between you and the company), according to the cases, can or must be communicated to the subjects or categories of subjects listed below:

- Public bodies for inspection and control activities, expressly delegated to them by the law or which are institutionally competent;
- Companies and professionals who carry out on our behalf the control and verification of accounting, or the management of payrolls
- Our trusted companies that carry out technical or organizational tasks on our behalf; the same is done by the subjects already indicated in this information to which the data is communicated.

**Geographical scope of processing:** Your personal data will always be processed within the European community.
